Mainstreet D&O: What You Need To Know

D&O Insurance provides coverage for companies and individuals against economic loss that may result from performance of their corporate duties. Common claims against Directors and Officers include shareholder derivative actions, class actions, employee and third party claims. Most of these claims encompass allegations of fraud, negligence, breach of fiduciary duty and board governance and/or regulatory violations. Several D&O policy types exist providing different coverages for these risks. In this session, a panel comprised of industry professionals will address the definition, key information and emerging issues and trends in the D&O Liability Insurance market.
